Warranty Registration Card

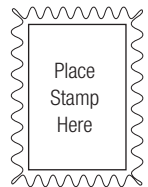

This warranty does not apply to damage or loss caused by any or all of the following circumstances or conditions:

- Damage caused during assembly or installation.
- Parts, accessories, materials or components used with or replacing any NEXTGEN part not obtained from or approved in writing by NEXTGEN.
- Misapplication, misuse and failure to follow the directions or observe cautions and warnings on installation, operation, application, inspection or maintenance specified in any NEXTGEN quotation, acknowledgment, sales literature, specification sheet or installation instruction and service manual ("applicable literature").
- Use of product in any other application other than those described in NEXTGEN's product information materials.

For this LIMITED WARRANTY to apply, NEXTGEN must receive notice of the alleged defect within 30 days of either the discovery of the alleged defect or the expiration of the warranty period, whichever is earlier. Any claim not made within this period shall conclusively be deemed waived.
